

Filing of your 2020 Income Tax Return

When: Tuesday, February 16 through Thursday, April 15, 2021

Because of the ongoing coronavirus pandemic, you will need a numbered ticket (*Seiriken* in Japanese) to get in the venue of filing. The ticket tells you when to come back to the venue for filing.

Tax offices are closed on weekends and holidays. Maebashi and Takasaki Tax Offices will be open on Sun., Feb. 21 and Sun. Feb. 28, 2021. They will accept filing of tax returns for residents under their jurisdiction as well as answer any questions regarding filing of 2010 income tax from all across Gunma over the telephone. See below table for their contact information.

As part of the COVID-19 spread prevention measures, you are requested to follow a few instructions to get in the venue of filing. Your cooperation is greatly appreciated.

Your temperature will be taken at the door. You will be denied entrance when the person managing the venue decides that you are a high risk to spreading the coronavirus on the grounds of the following reasons.

- 1) your temperature is **37.5 degrees C or higher**
- 2) you are **showing common cold-like symptoms** like coughing
- 3) you **refuse to have your temperature taken**

Also,

You are asked to **wear a mask at all times** and **use hand disinfectant** at the entrance.

You are requested to **come alone to the venue**.

If you need a caregiver to come to the venue, please **try your best to minimize their number**.

If you are denied entrance due to one or all of the reasons above, you can always come back later.
