

2021 Income Tax Return (List of filing venues in Gunma)

The filing period of your taxable income for the calendar year 2021 is:

From: Wednesday, February 16
To: Tuesday, March 15, 2022.

You need a **numbered ticket (Seiri-ken in Japanese)** to enter your venue of filing, unless you are there to submit papers only. These numbered cards are given to limit the number of visitors at filing venues as part of the ongoing pandemic countermeasures. They are issued **either at the entrance of the venue** (on the day of your filing) or **online** (in advance). Check LINE app on your smartphone/computer that tells you how to get them. Also, note that the explanation on LINE is in Japanese.

When you visit the venue, you may be asked to come back later because the day's tickets are all handed out. If you don't want this to happen to you, you can check the status of their availability online. Visit the website of the National Tax Agency (*Kokuzeicho in Japanese*).

Tax offices are closed on weekends and holidays. During the filing period, however, you can file on weekends at two of the designated venues set up by Maebashi and Takasaki Tax Offices, on **Sun. Feb. 20** and **Sun., Feb. 27, 2022** to be specific.

The usual COVID-19 preventive measures are in place at all tax filing venues of Gunma.

*Temperatures will be taken at the entrance without exceptions. You may be denied entrance in cases like having a fever of 37.5 degrees C or higher, coughing, or refusing to have temperatures taken.

*If you are showing common cold-like symptoms or feeling unwell, please reschedule your visit after you feel fine again.

*You will be asked to disinfect your hands at the entrance and wear a mask at all times while you are inside the venue.

*Please do not accompany anyone to the venue.

*If you require an assistance of a caregiver to complete the filing, it would be appreciated if you could limit the number to a minimum.
